

IMPORTANT TAX INFORMATION

Tax-Exempt Income Distributions: Exemptions from Federal and State Income Taxes

Please note that exempt-interest dividends paid by the Funds in 2020 are exempt from Federal Income Tax and are reported in **Box 11** of Form 1099-DIV.

A portion of your 2020 income distributions may also be exempt from State Income Tax. You will need to utilize the state-specific percentages presented in the "Tax-Exempt Investment Income by State" table to determine this amount.

Please consult your tax advisor regarding the tax status of Fund distributions in your state.

Important Alternative Minimum Tax Information:

The percentage of your total 2020 exempt-interest dividends subject to the Alternative Minimum Tax ("AMT") is shown on the line "Amount Subject to AMT" at the bottom of the "Tax-Exempt Income by State" table. In addition, any exempt-interest dividends subject to the AMT are shown in **Box 12** of your Form 1099-DIV, labeled "Specified private activity bond interest dividends."
